Outlook for the day

The market is expected to open on a cautious note today after a sharp slump in the previous session and amid mixed global market cues. Stocks in Asia look set for a mixed day with traders hoping for another positive session in China while Japan markets opened lower. Japanese shares slipped and government bond yields surged following slightly more hawkish tone by the Bank of Japan. The S&P 500 climbed to a record high close on Tuesday as investors digested a mixed bag of early quarterly results and awaited a slew of additional reports from Tesla and other companies later this week. Oil prices fell on Tuesday, handing back some of the previous day's gains, as traders weighed rising crude supply in Libya and Norway against production outages in the United States and geopolitical tensions. Back at home, DLF, Bajaj Auto, Tata Steel, Tech Mahindra, TVS Motor, Canara Bank, Indian Oil, Container Corp, Balkrishna Industries, UCO Bank, Dalmia Bharat, Bharat Dynamics, Exide Industries, Chalet Hotels, Railtel Corp, CEAT, Sharda Cropchem will release quarterly earnings today. As per provisional figures, Foreign Institutional Investors (FIIs)/ Foreign Portfolio Investors (FPIs) sold shares worth net Rs.3115.39 crore and Domestic institutional investors bought shares worth net Rs. 214.40 Crore on 23rd January 2024.

Macro news

Euro area consumer sentiment deteriorated unexpectedly at the start of the year, after improving in the previous two months, preliminary data from a survey by the European Commission showed Tuesday. The flash consumer confidence index fell to -16.1 from -15.0 in December. Economists had expected the score to improve to -14.3. The corresponding index for the EU eased to -16.2 from -16.0. Both readings are well below their long-term average, the EU said. Data for the latest survey was collected from January 1 to 22. The final reading for consumer confidence is set to be released along with the monthly economic sentiment survey on January 30.
